### **OTHER REQUIREMENTS:**

- **LANDSCAPE**: Must be installed by the Builder or Owner within 30 days, weather permitting, after substantial completion of residential dwelling. Landscape plans must include the location, type and size of trees, plants, ground cover (no perma-bark or rock is permitted), shrubs, berms and mounding, grading, drainage, sprinkler system, water features, outdoor kitchens and fireplaces, fences, free-standing exterior lights, driveways, parking areas, and walkways.
- **GRADING/DRAINAGE**: Buyer agrees to complete all finish grading in a manner that will collect all drainage waters onsite and to prevent surface water migration. Lots 66-72, 74-77, 79, 80, 85-92 subject to Lot drainage collection system. All common areas must be considered.
